1. Reversionary Trust Interest, 12 USC 95(a)
2. Regulation Z
3. Lawful Money
4. The Enabling Clause, before every Act of Congress
5. The Brother's Keeper Clause, 18 USC 241 and 242
6. West Virginia v. EPA (2022) and antecedent case Norton v. Shelby County, 118 U.S. 425 (1886)
