DECREE OF ADOPTION

This matter coming on for hearing before the Court on the 14th day of March, 1990, upon the Petition of Adoption of SIGMUND J. PAWELEC and LUZ PAWELEC, Petitioners being present in Court and being represented by GERALDINE KIRK-HUGHES, ESQ., said Petitioners having been examined under oath, and the Consent of Adoption of the said minor children by the natural mother, one of the Petitioners herein, having been filed herein; and the parental rights of the natural father of said minor children having been terminated on the 14th day of March, 1990, by an Order issued out the Judicial District Court of the State of Nevada, in and for the County of Clark, a court of competent jurisdiction, and being Case No. D124818 and the Court having previously entered its Order waiving and dispensing with an investigation and report of the Nevada State Welfare Department, and finding all documents in all respects proper, and finding

1 that all of the allegation of said Petition are true; that
2 Petitioners are husband and wife; that Petitioners have been
3 residents of County, Nevada, for periods of 10 years
4 respectively, prior to the filing of their Petition; that said
5 minor children resided with Petitioners for more than six (6)
6 months prior to the granting of this Decree of Adoption; that
7 the Petitioners are 37 and 33 years of age,
8 respectively, both Petitioners being more than ten years older
9 than the said minor child; that the Petitioners are financially
10 able to provide for the support and maintenance of the minor
11 child; and its further appearing to the satisfaction of the
12 Court that the best interests of said child will be prompted by
13 said adoption; that there has been a full compliance with the
14 laws of the State of Nevada relating to adoptions and a full
15 compliance with N.R.S. 127.220 to 127.310, inclusive;

16 NOW THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED
17 that the said minor children is hereby declared to be adopted by
18 Petitioner, SIGMUND PAWELEC, that said minor children shall
19 henceforth be regarded and treated as Petitioner's natural
20 children and have all the lawful rights as his own children,
21 including the rights of support, protection and inheritance, and
22 that said minor child, MONIKA ROSALES, shall henceforth bear the
