It is against the law for me to vote in your corporate elections and / or maintain any affiliation with your organization that may cause a misunderstanding of my willful and rightful political status change from the assumed U.S. Citizen/citizen to that of a proud, true American, with a declared status of American State National/Citizen.

Failure to act as requested will result in further escalation of this matter. I do require that you send me an autographed statement or other further proof that my request has been fulfilled. Upon receiving that autographed statement from you or a Committee representative, I will ignore and not act further upon any future mailings that may inadvertently be pending in your system.

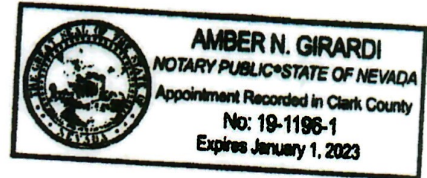
