To all to whom these presents shall come:

I, a woman Michelle Lynn Schmidt a creation of Nature's God, standing on the land and soil of the organic states united by the Articles of Confederation, (1781) as a beneficiary of the American Public Law, serve this Declaration of Provenance and Jurisdiction Notice, written in common American English; and

I, a woman, Michelle Lynn Schmidt prove my Provenance, Jurisdiction, status and standing by my public record at: <https://members.americanstatenationals.us/member/?pid=&tab=documents> and all documents therein are made part of this notice as if set forth in full; and

I a woman Michelle Lynn Schmidt> as an American State National, hereinafter "ASN," hold sole survivorship interest in my estate, I am not nor am I representing any corporation, I object to the use of Federal Reserve Notes, my Court has superior concurrent general jurisdiction, I am not subject to any incorporated government nor foreign laws such as United States Code or Nevada Code see Articles #4588 and #4539 at <https://annavonreitz.com>, articles on that web page herein will be cited "#XXXX," nor a "person subject to service of process," nor taxes under said codes nor a citizen of the United States nor government employee, any presumption from mailing address, see #4501 page 5, or government ID issued without full disclosure notwithstanding, my return service is your void jurisdiction notice; and

I, a woman as an ASN require pass through service, am a claimant not a complainant, respondent or defendant, as Preferential Priority Creditor, see, Public Law A1010124 at <https://tasa.americanstatenationals.org/federal-record/> and Article #4473, ,I do claim my property and my credit both here and now, with the Private Indemnity Bond number AMRI00001 RA393427640US-New York, on file with the United States Treasury, Article #3061, I do demonstrate my private capacity in my original jurisdiction and I have first hand knowledge to declare as follows:

1. Whereas: <https://annavonreitz.com> is a public record for The United States of America unincorporated Federation of united States of America, all links therein are part of this notice as if set forth in full, said links contain abundant notice, law and facts of the crimes committed against the American People by those persons purporting to be our government, see #1, #1105, #3061, #3112 #3487, #3564, #3711, #3716, #3717, #3755, #3763, #3936, #4083, #4340, #4342, #4385, #4393, #4405, #4406, #4473-#4491, #4667, #4689; and

2. Whereas: you seem to be ignorant of who I am, where I am, and that your claim of jurisdiction is fraudulent, see Public Law A1010124 at <https://tasa.americanstatenationals.org/federal-record/> and I provide these excerpts from #3680 The Public Employer's Directive, and then State Citizenship Case Law:

1. First, we, Americans populating the States of the Union, are your Employers;

4. We, Americans, your Employers, do not reside in your States-of-States; instead, you reside in our physically defined States of the Union;

11. The private laws promulgated by your State of State Legislatures to direct the functioning of your governmental service corporations are foreign with respect to your Employers and what applies to you "as law" as a condition of your employment or dependency, does not, generally, apply to your Employers;

33. We, your Employers, have never granted our Employees any authority to impersonate us so as to access our credit, ...nor to misaddress us via your own foreign courts, and we have not knowingly, willingly, and with full disclosure ever agreed to enfranchise ourselves or our assets as collateral belonging to any foreign corporation, bankrupt or otherwise;

State Citizenship Case Law:

United States v. Cruikshank, 92 U.S. 542, 549 (1875) "We have in our political system a government of the United States and a government of each of the several States. Each one of these governments is distinct from the others, and each has citizens of its own who owe it allegiance, and whose rights, within its jurisdiction, it must protect. The same person may be at the same time a citizen of the United States and a citizen of a State, but his rights of citizenship under one of these governments will be different from those he has under the other."

U.S. v. [Susan B.] Anthony, 24 Fed. Cas. 829, 830 "...an individual can be a Citizen of one of the several states without being a citizen of the United States," or, "a citizen of the United States without being a Citizen of a state." (Slaughter-House Cases, supra; U.S. v. Cruikshank, 92 US 542, 549 (1875)).

Twining v. New Jersey, 211 US 78, 98-99 "The right of trial by jury in civil cases, guaranteed by the Seventh Amendment ..., and the right to bear arms guaranteed by the Second Amendment ..., have been distinctly held not to be privileges and immunities of citizens of the United States guaranteed by the Fourteenth Amendment against abridgment by the State, and, in effect, the same decision was made in respect of the guarantee against prosecution, except by indictment of a grand jury, contained in the Fifth Amendment ..., and in respect of the right to be confronted with witnesses, contained in the Sixth Amendment.";and

3. Whereas: The Constitution for the united States of America 1787 requires that, "No State shall... make any Thing but gold and silver Coin a Tender in Payment of Debts;..." Article I Sect.10 Clause 1; and

4. Whereas: your State of State uses Federal Reserve Notes and not gold and silver Coin, you are outside your Article I Sect.10 Clause 1 delegation of authority to claim jurisdiction over ASNs; and

5. Whereas: you have no full disclosure contract, maritime or otherwise where I gave you jurisdiction over me or my estate to call me any fraudulent NAME, or gave up my rights and status as a native born Californian; and

6. Whereas: your courts have made fraudulent claims and converted our ASN status and rights, to falsely assume jurisdiction over ASNs, a war crime, a fact agreed to in #0024 line 157, and in Geneva and Hague conventions; and

7. Whereas: this notice and especially #3733, Public and International Notice of Trespass and Breach of Trust, served to many United States officials and all State of State governors in June of 2022, are UCC 1-202 notice and no United States principles or citizens or agents, hereinafter "Agents," can claim ignorance of above notice contents; and

8. Therefore: the State of States are United States corporate commercial franchises, not the organic American states addressed by Article I Sect.10 Clause 1 above, a fact agreed to in #0024 "franchises" line 137; and

9. Therefore: ancient Maxims of Commerce apply, see <https://steemit.com/law/@samsunglg7413/maxims-of-law> and #0087 Affidavit of Obligation and Commercial Lien against the American Bar Association, Maxims 1-23; and

10. Therefore: the judgment of the circumstance and events established as fact for all purposes and



in all venues on the 9<sup>th</sup> of August 2023 as evidenced by article #4324 <http://annavonreitz.com/noticeanddemandamericancivilwar.pdf>, are hereby amended to include the facts, law, notices, terms and conditions in this notice, void for fraud any past and estop any future claims, by you or any other Agents, that fail to recognize the status and standing of ASNs, as being outside Agents jurisdiction;

11. Therefore: (a) any future failure to recognize the status and standing of ASNs, as being outside your jurisdiction, by you or any other Agents, will be deemed personage, an act of war, and by this notice your agreement to the facts, law and notices herein and a True Bill issued against you, and any and all said Agents individually, per each occurrence, at ten million dollars (\$10,000,000) lawful money of The United States of America, (b) use of any form of my name other than that which I use herein will be billed each, as above at one million dollars (\$1,000,000) as will be kidnapping per day, (c) any other unwarranted actions, inactions, false statements or presumptions against ASNs, will be billed each as above at one hundred thousand dollars (\$100,000) each; and

12. Therefore: without an ASN's explicit consent, not you nor your Agents, have authority to take any action affecting ASN's or their property, any action or order by any State-of-State or United States Agent notwithstanding; and

A copy, facsimile or digital scan of this Declaration of Provenance and Jurisdiction Notice shall be as legally binding as an original, is true complete and correct to the best of my knowledge and I so declare under Penalty of Perjury under the Public Law of The United States of America (unincorporated).


