I, Michelle Lynn Schmidt, a Living Woman and Vital Soul, *extend cordial, amicable, peaceable and honorable greetings to you this* 19th *day of* September *Two-Thousand and Twenty-Three.*

I wish to provide you with Lawful Due Notice and Testimony, under solemn Attestation and Witness of The Public Law of The United States of America, and Establish the same upon the Public Record that the following are absolutely true and correct to the best of my knowledge and belief:

- 1) that I am a Peaceful, Non-Belligerent, Non-Combatant, Third-Party Civilian, American State Citizen, Impost, Duty and Tax Prepaid Priority Creditor, Inheritor of and Living and Present Heir to the **Trust Indenture** established by "The Unanimous Declaration of Independence, 1776", Member of the "Political Community" known as "The People," and Actual Being-In-Possession and Naked Owner who is owed amity, protection of my life and property, good-faith service, immunity, and aid from all Employees, Officers, Agents, and subcontractors of the British Territorial United States and the Municipal "UNITED STATES", military and civil, and;
- 2) that I am not now, nor have I ever been a British Territorial "U.S. Citizen" or Roman Municipal "citizen of the U.S." or any other variety of Federal United States "person, officer, employee or elected official"
