After reviewing the Billing Summary and Notice to file a tax return, it has come to my attention that you and your Officers or OFFICERS are misaddressing me and are impersonating me. You and your Officers or OFFICERS are attempting to revenue a Usufruct Derivatives that you are not authorized to use. I own both copyright and trademark to the vessels: Lora Danielle Kelsey, Lora D. Kelsey, Lora Kelsey, LORA DANIELLE KELSEY, LORA D. KELSEY and DANIELLE KELSEY. This is fraud, theft and criminal.

Enclosed: CERTIFICATE OF ASSUMED NAME, MANDATORY NOTICE, Deed of Re-Conveyance, and Criminal Information Claim and Notice of Liability. If you and your Office or OFFICE wish to decline contract with my vessels; I require a Notice of withdrawal.

A copy, facsimile or digital scan of this Notice of Misaddressing and Impersonation shall be as lawfully binding as an original, is true complete and correct to the best of my knowledge and I so declare under Penalty of Perjury under the Public Law of The United States of America (non-incorporated).

If 26 U.S.C section 3402 is the Tax code for 'Tax Withholding' then I would like to bring you attention to the definition of 'Employee' in **26 U.S.C section 3401 (c) says: Employee**

For purposes of this chapter, the term "employee" includes an officer, employee, or elected official of the United States, a State, or any political subdivision thereof, or the District of Columbia, or any agency or instrumentality of any one or more of the foregoing. The term "employee" also includes an officer of a corporation. - Given this definition in your law, I do not qualify as an employee, because I do not work for the federal government. I ask, do you think, I, a living woman, work for the federal government?

26 C.F.R Section 601.602 says: The tax system is based on voluntary compliance - So I have sent in my 'Revocation of Election to Pay Taxes'. I ask, what part of 'voluntary' do you not understand?

26 U.S.C. section 7851 (a)(6)(A) says: There is no authority for the IRS to use any 'enforcement' actions, against an American National / non "U.S. citizen" (meaning D.C. citizen) like me (with no government sources of excise taxable income connected to a "trade or business" and acting in the capacity of a "public officer").

Until Title 26 becomes "ENACTED" - meaning – passed into "positive" law and then made applicable to the living people domiciled in the 50 states of the union (will never happen), nothing in Title 26 applies to the living men and women in the states of the union – not involved in excise taxable activities. If Title 26 has never been "enacted" into 'positive' law, then how is it possible for the IRS's letter to apply to we, a living man and woman, living under our Creator's laws protected by the *de jure* Constitutional (1787) **law of the "land" jurisdiction** in a non-domestic (not within D.C.) state of the union and with a mailing location not within the "United States" (defined in tax law as D.C.) and their **Admiralty law of the "sea" jurisdiction?**

Michael L White, a Federal Attorney, wrote in a letter that said: There are no enforcement regulations in the Federal Register – nor a requirement to pay income taxes. Your office and the IRS are required by law to have a knowledgeable IRS officer provide me with the IRC regulation in Title 26 or in any other U.S.C. Title that makes us "subject to" and "liable for" for anything.

26 U.S.C. section 7806(b) says and I paraphrase: There is no inference that any regulation in Title 26 has any force and effect in law. Doesn't this code section sound 'Frivolous' to you?

26 U.S.C. section 7408(d) says the IRS's taxing jurisdiction is limited to the ten square mile area commonly known as the District of Columbia. Does the IRS think we, the living man and living woman, are domiciled in D.C. or in any one of its possessions or territories, or within one of its "federal zones" within the state where I live?

4 U.S.C. section 72 says the IRS tax code is not allowed to leave the ten square mile land area of the District of Columbia. Does the IRS office that sent the the letter with no basis of law, is making a claims

- think I am domiciled or living in the District of Columbia? I have never lived nor knowingly been domiciled in D.C. and I have never knowingly been a "public officer" involved in a "trade or business" domiciled in D.C.

Does the IRS officer, making these claims, have a license to practice tax law? Is your office making a "legal" determination, without lawful discovery, as to what I am "liable" for?

1 U.S.C. section 204 says Title 26 is not "positive law" (never enacted beyond one day in August 1954) and therefore, is only "prima facie" and "color of law" evidence (evidence is not proof), but a mere statutory "presumption" [by the IRS]. The IRS cannot impair my constitutionally protected – God given unalienable rights [to not volunteer to make donations to the Treasury]. [emphasis added]. Does your office think Title 26 has been "enacted" into positive law and therefore, somehow applies to we, the living man and living woman?

IRC code section 7206 – Fraud and False statements. Any [IRS] person who willfully aids or assists in making a "claim" [for amounts due] which is fraudulent or is false as to any material matter, shall be guilty of a felony – fined not more than \$100,000 and imprisoned not more than 3 years, or both, together with cost of prosecution.

3) Whereas: your corporation is misaddressing me with a Usufruct Derivative, and used my name to create franchises without contract and for its own benefit --- which by law it can only do if it holds me harmless from any damage or claim arising from its action, see #4708 page 2 link; and

4) Whereas: there has also been a pernicious practice of pretending that there is a war on and that I, or rather, these foreign corporation franchises named after me, are involved in such a "war", see #4324 page 5; and

5) Whereas: it turns out that the war is a Mercenary Conflict owed no dignity or authority under the Law of War and that the commercial companies involved are simply derelicts operating under conditions of fraud and deceit, see #4722; and

6) Whereas: Ancient Commercial Law applies: <https://famguardian.org/TaxFreedom/CitesByTopic/MaximsOfCommerce.htm> ; and

7) Therefore: you, your Principals and any incorporated State or United States agents, hereinafter "Agents," are without contract and fully informed, in the criminal sense of the word, that I am not a corporation, corporate franchise or representing any corporation; and

8) Therefore: I am not an Enemy of any sort, am in fact your Employer, see #3680 number 4, and if you pretend to represent my government in any capacity whatsoever I require a guarantee of full disclosure under oath or affirmation; and

9) Therefore: I object to the use of Federal Reserve Notes as a matter of law and principle, see #4700 and 12 USC 411; and

10) Therefore: I demand you hold me harmless from any consequence of your action(s) creating franchises named after me, see #4719 page 3; and

11) Therefore: per #4721 Judgment page 7 and UCC 1-202, I "...require that corporate administrative tribunals being operated as courts of any kind explicitly and fully declare their identities, natures, venues, services, ownerships, and proper jurisdiction in plain, explicit, fully revealed language with no further purpose of evasion, obstruction, or lack of good faith service."; and

12) Therefore: by operation of law the judgments, facts, law, notices, terms, and conditions in this Criminal Information, Claim and Notice of Liability, void for fraud any past and estop any future claims, by Agents that fail to recognize the status and standing of American State National's, hereinafter ASNs, as being outside Agents jurisdiction and not a person subject to Agents codes, legal definitions, or service and or "words of art"; and

13) Therefore: I do not accept solicitations, see #4721 Judgment page 7, and as a Preferential Priority Creditor, see #4473 I claim the following damages if Agents do not cease and desist from identity theft and or misaddressing me from a foreign jurisdiction; and

14) Therefore:

a) any future failure by Agents to recognize ASNs status and standing as being outside their jurisdiction, and or absent a guarantee of full disclosure will be deemed a mercenary crime, and Agents agreement to this Criminal Information, Claim and Notice of Liability, to the judgments, facts, law, notices, terms, and conditions hereinm, right to accelerate at will and to a True Bill issued against you, and any and all said Agents individually, per each occurrence, at ten million dollars (\$10,000,000) lawful money of The United States of America; and

b) Agents use of any form of an ASN's name other than that which I use herein will be billed each, as in a) above at one million dollars (\$1,000,000) as will be kidnapping per calendar day or part thereof; and

c) any other unwarranted actions, inactions, false statements or presumptions by Agents against ASNs, will be billed each as in a) above at one hundred thousand dollars (\$100,000) each; and

15) Therefore: without an ASN's explicit consent, no Agents have authority to take any action affecting ASNs or their property, any action or order by any incorporated State or United States Principles or agents not withstanding; and

A copy, facsimile or digital scan of this Criminal Information, Claim and Notice of Liability shall be as lawfully binding as an original, is true complete and correct to the best of my knowledge and I so declare under Penalty of Perjury under the Public Law of The United States of America (unincorporated).
