To Whom it may concern:

Thank you for the opportunity to respond to your letter, of which I have accompanied with this document.

**- This is your first notice of Trespass -
Notice to agents is notice to principals and notice to principals is notice to agents.**

1. I would like to clear up the fact that you are presuming I was a U.S. citizen from birth... There are NO "Fourteenth Amendment Citizens". The so-called Fourteenth Amendment citizens don't exist. The "Constitution" that this Amendment is part of, was in fact the Articles of Incorporation of The United States of America, Inc., which was chartered in Scotland in 1868 and bankrupted in 1907. It was never ratified by the States and has nothing to do with the States, nor the People of this country. Fourteenth Amendment citizens don't exist. What they are talking about is a "political status", a capacity, which we may choose to undertake or not. The original Municipal Citizen political status was created by The Constitution of the United States and provided for Holy Roman Empire employees to be here providing "essential government services" --- nothing more or less. The adjunct political status "citizen of the United States" was created for Negroes in the wake of the Civil War as a means of seizing upon and enslaving them to pay the debts of the Confederacy. Thus, there came to be two kinds of "Citizen of the United States" --- the original Federal Civil Service Employees and their Dependents, and the new crop of slaves known as "citizens of the United States" --- termed "Fourteenth Amendment citizens of the United States". The freed Negro population needed to have some kind of political status, so the Congress "conferred" US Citizenship on them rather than struggle with the individual States trying to make the States accept them as State Citizens. I am neither a slave nor a negro!!

The fact is, that no present-day presumption against us can be maintained on the basis of Fourteenth Amendment "citizenship". If you aren't black and aren't either working for the Municipal Government and/or receiving unearned welfare checks from the Municipal Government, you couldn't possibly be in the political status of a Fourteenth Amendment citizen in the first place --- by definition.

2. I am not an individual or an organization. DO NOT mischaracterize me as a "person". The duty to issue a correct passport to me, Lora Danielle Kelsey, remains as one of the "essential governmental services" required under international law and at Article IV, Section 3, Clause 2 of The Constitution for the United States of America, of which I am a beneficiary. I am a living woman, and surviving heir to my estate and the Trust Indenture as a Nevadan and member of the general public. Therefore I hold superior concurrent general jurisdiction over this country and ultimately I am your employer, subsequently making you subject to my jurisdiction. So when you refer to 'supreme law of our land', you would be referring to American Common Law in the Land and Soil jurisdiction.. Not the United States Code or statutes... You are providing a service to me as a public servant and as I am not a U.S. citizen or Citizen of the United States, the next best option for me would be issuing me a United States National passport... There have

been thousands of American's who have acquired this passport using the same method of completing the DS-11 as I have previously done.

3. That fact is, by your law USC 8 1101 (23) I can "confer my naturalization... **BY ANY MEANS WHATSOEVER**"!! So given that I was the victim of the criminal malicious act of fraud where I was kidnapped from the land of my birth and into the foreign international jurisdiction of the sea, by way of the registration of a Birth Certificate — an act of press-ganging and inland piracy and unlawful conversion of my political status, which you are now an accomplice too.

We have 2 options moving forward:

Option 1: You process my previous DS-11 and give me a United States National Passport. As I have instructed you to do. (Obviously the easier option as you have done this for thousands of American's prior to this.)



Or

Option 2: With no other choice, but to fill in the DS-11 as you instructed, thus forcing me to commit 'perjury' saying that I am a U.S. citizen, and that I live in the District of Columbia. When as a matter of Fact, I do not live in any Federal Enclave, do not reside in any municipal nexus, and in fact Zip Code exempt — Title 39 U.S.C. Section 3003, 1341, 1342, which is punishable by up to 15 years imprisonment and \$1,000,000.00 fine. Use of ZIP CODE is voluntary. (Domestic Mail Services Regulation Section 122.32 Nondiscrimination for NON-USE of) and ZIP CODE per Public Law 91-325, section 403. And if you give me no other option but to "lie" to get a passport, so therefore I am signing this document 'under duress'.

In conclusion The New Hampshire passport office has been offering to obstruct my ability to travel freely for months over these petty obstructions and refusals to provide services owed and failure to obey the Public Law. This is in itself a crime against humanity and an insufferable mis-administration of essential governmental services which are owed to me and to all American Nationals.


If we cannot come to terms, then please send back all documents, old passport and passport fee. To keep my payment and not provide a service, that you are contracted to do, is a trespass by way of "Theft". I will then take this up with the U.S. Secretary of State and the U.N. Secretary General.
