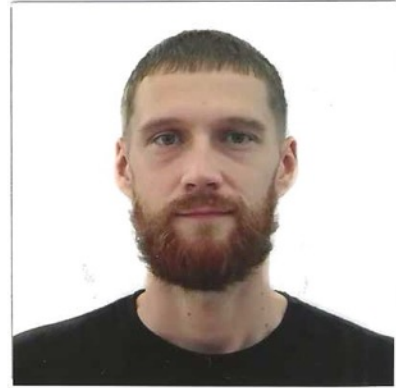


Witness Testimony Affirming American State Political Status and Identity


