Hello!

I have attach my Declaration of Political Status, letter to Secretary of State of Washington DC, Antony Blinken, and letter to Assistant Sec of State for Consular Affairs, Rena Bitter, confirming my political status. I have studied the instructions and your laws for issuing the different types of passport and therefore the way I filled out the DS-11, is accurate and true, and any changes made to it, would be a lie, and therefore 'perjury'.

I would like to clarify some points in advance. If you are unaware of any of these, please talk to your supervisor and legal team about the specifics.

1. I would like to clear up the fact that, you are most likely, presuming I am a U.S. citizen... **There are NO "Fourteenth Amendment Citizens"**. The so-called Fourteenth Amendment citizens don't exist. The "Constitution" that this Amendment is part of, was in fact the Articles of Incorporation of The United States of America, Inc., which was chartered in Scotland in 1868 and bankrupted in 1907. It was never ratified by the States and has nothing to do with the States, nor the People of this country. Fourteenth Amendment citizens don't exist. What they are talking about is a political status, a capacity, which we may choose to undertake or not. The original Municipal Citizen political status was created by The Constitution of the United States and provided for Holy Roman Empire employees to be here providing "essential government services" --- nothing more or less. The adjunct political status "citizen of the United States" was created for Negroes in the wake of the Civil War as a means of seizing upon and enslaving them to pay the debts of the Confederacy. Thus, there came to be two kinds of "Citizen of the United States" --- the original Federal Civil Service Employees and their Dependents, and the new crop of slaves known as "citizens of the United States" --- termed "Fourteenth Amendment citizens of the United States". The freed Negro population needed to have some kind of political status, so the Congress "conferred" US Citizenship on them rather than struggle with the individual States trying to make the States accept them as State Citizens. **I am neither a slave or a negro!!**

The fact is, that no present-day presumption against us can be maintained on the basis of Fourteenth Amendment "citizenship". If you aren't a negro and aren't either working for the Municipal Government and/or receiving unearned welfare checks from the Municipal Government, you couldn't possibly be in the political status of a Fourteenth Amendment citizen in the first place --- by definition.

2. I am not an individual or an organization. DO NOT mischaracterizing me as a “person” and that the duty to issue a correct passport to me, Zackery James Cross, remains as one of the “essential governmental services” required under international law and at Article IV, Section 3, Clause 2 of The Constitution for the United States of America, of which I am a beneficiary. **I am the living man, and surviving heir to my estate and the Trust Indenture as a Illinoisan and member of the general public.** Therefore I hold superior concurrent general jurisdiction over this country and ultimately I am your employer, subsequently making you subject to my jurisdiction. So when you refer to ‘supreme law of our land’, you would be referring to American Common Law in the Land and Soil jurisdiction.. Not the United States Code or statutes... I am owed good faith service from all Federal citizens and franchises, and as I am not a U.S. citizen or Citizen of the United States, the next the best option for me would be issuing me a United States National passport for an American that is called a "Specially Designated National" in your system of things.... There have been thousands of American’s who have acquired this passport using the same method of completing the DS-11 as I have provided.

3. That fact is by your law 8 USC 1101 (23) I can “confer my naturalization... by any means whatsoever”!! I am well aware of the millions of victims of the criminal malicious act of fraud where they were kidnapped from the land of their birth and into the foreign international jurisdiction of the sea, by way of the registration of a Birth Certificate. This is an act of press-ganging and inland piracy and unlawful conversion of their political status. For this reason I DO NOT want any part of being a U.S. Citizen or Citizen of the United States. I returned to by birthright political status as an American State National, this I declare under penalty of perjury under the Public Law of The United States of America.

If you need anything else please do not hesitate to contact me. In conclusion thank you for you service and not obstructing my ability to travel freely and subsequently obeying the Public Law and your constitutional contracts. You are providing essential governmental services which are owed to me and to all American Nationals, and for this I am very grateful.

In the unfortunate event that we cannot come to terms, then please send back all documents and fees, otherwise I will consider this a trespass against me and breach contract for not providing essential government services. I will then take this up with the U.S. Secretary of State and the U.N. Secretary General.
