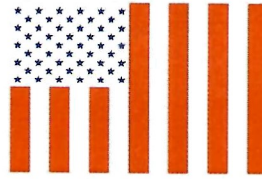

Notice of Fault and Opportunity to Cure

Dated this 4th day of May, 2023;

You are in receipt of a Directive mailed on April 16, 2023. Directive for Immediate Cease and Desist the Release of all Chemicals Into the Atmosphere and/or Stratosphere and Environmental Contamination Including Radio Frequency/Microwave Radiation; as issued by the People on the Land and Soil Jurisdiction of Nevada;

Representation and Warranties

Your failure to rebut the aforementioned directive to 'cease and desist' becomes your acknowledgement that our fees are now due and will continue to accrue;

By not responding, you have acquiesced that you are in violation of the people's constitutionally protected rights, the laws of the United States, and the public laws of Nevada;

If you do not respond to this second Notice/Directive, Notice of Fault and Opportunity to Cure, a default and judgment is rendered, thereupon your non-response is your tacit agreement for the violations contained therein and you will be barred by res-judicata for making decisions that impact the quality of the Nevada airways. If you default, this will serve as an automatic writ of arrest for the violations of spraying and contaminating our airways, water, and land;

Any and all parties alleging any type or form of contractual relationship in this matter have the burden of proof of such and are required by law to present such upon this instant demand; and that failure to respond in ten (10) days in accordance to the Administrative Procedures Act of 1946 is accepted as lawful and legal acquiescence and willful agreement that neither you personally, nor your office, nor any corporation have jurisdiction regarding Nevada airways, water and land;

Wherein for you, and each of you receiving this administrative process, have ten (10) days upon the verified date of receipt of this mail article to respond;

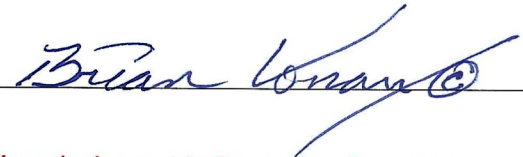
