Acknowledgment, Acceptance and Deed of Conveyance

1st Paragraph	Establishes the fact that you are a living soul, of sound mind and body from birth state soil to the present soil you live on.	You are re-conveying all names and NAMES from any presumption of being lost at sea and firmly establishing them on the soil.	Record in Land Recording Office
2nd Paragraph	Revokes all Powers of Attorneys that you may have knowingly or unknowingly granted, as well as executorships, guardianships and agency relationships when dealing with the Corporation(s).	Releases you from any presumption that you have authorized to the Corporations(s) any Power of Attorney, Executorships, Guardianships or Agency Relationships and firmly establishes that you are the sole living owner, executor, beneficiary and agent of your name and estate since your 21st birthday.
